# Purpose of RFP

- Improve Energy Portfolio Management through outsourcing by improving the capability to:
  - Scheduling and settling energy in ERCOT
  - Offload excess power (hedging, trading, bi-lateral contracts)
  - Report positions, exposure and risk (daily, monthly, yearly)
  - Forecast and budget
  - Monitor ERCOT transmission



## Challenges with current, insourced model

### Complexity

- Intended a relatively simple, easy to manage portfolio
- Change in market conditions increased complexity and requires more complex management

## Shortfalls to meeting complexity

- Insufficient current staff & consulting size, depth and breadth
- Lack supporting enterprise application

## 2-Step Selection Process

- RFP issued February 8,2019 and due March 7, 2019
- Step 1: 12 Bidders responded
- Step 2: Top 3 interviews and Best and Final Offer
- Independent scoring
- Joint selection
- Coordinated by Purchasing
