### 2017 - Five Year Extension

- 5 Year Extension of 2012 Contract
  - Timing
    - September 2017
  - Modifications
    - New Refuse Rate Index
    - Add Commercial Recycling (optional, but exclusively provided by City)
    - Evaluating pricing options for Brushy Waste drop-off
    - Considered making Roll-Offs exclusive but temporarily paused



#### New Price Index

- Refuse Rate Index (RRI)
  - Growing use nationally
  - Basket of Indices
    - #2 Diesel: Bureau of Labor Statistics the Producer Price Index (BLS PPI)
    - Vehicle & Equipment Replacement: (BLS PPI)
    - Labor Cost: (BLS Monthly Labor Review for Employment Cost)
    - Repair & Maintenance: (BLS PPI)
    - All Other: BLS Consumer Price Index (CPI)
