




Project Location and General Description

Project Description

- 278 acres
- 600 SF Lots
- Amenity Center
- More than 80 acres of open space, including 22 acres of Parkland along River





First Amendment to Consent Agreement

The Amendments to the 2016 Consent Agreement:


- Address traffic signalization at River Terrace Drive and SH 29 Intersection
- Address residential architectural and masonry requirements (same as PUD Ordinance)
- Provide deadlines for construction of the San Gabriel River Trail
- Increase Bond Amount Limit from \$19.9M to \$26M
- Replace Water Service Agreement (this is a stand-alone agreement but is referenced in and attached to the Consent Agreement)



Traffic Signalization

Existing:


•No Developer obligation to fund the design and construction of a traffic signal at the intersection of SH 29 and River Terrace Drive (the subdivision entrance).



Traffic Signalization

First Amendment:

- •First 4 years Developer to conduct annual warrant studies if the warrant study shows that a traffic signal is required, the Developer will post fiscal to cover the cost of the signalization.
- •After 4 years no more warrant studies, but the Developer will be required to post fiscal to cover the future cost of the signalization.



Residential Architectural and Masonry Standards

Existing:

•Residential Development Standards are only in the Planned Unit Development (PUD).

First Amendment:

•Residential Development Standards are carried forward in the Consent Agreement (without changes from the PUD).





South San Gabriel River Trail


Shadow Canyon has approximately 1 mile of river corridor frontage

Existing:

•No commencement deadline; development-paced deadlines for completion.

First Amendment:

- Add a commencement deadline of May 31, 2022
- Add a completion deadline of December 31, 2022.



Bond Amount Limit

Existing:

Bond Amount Limit = \$19,900,000.

First Amendment:

Bond Amount Limit Amount = \$26,000,000



No other changes to financial terms:

- Maximum Bond Maturity: 25 years [NC]
- Bond Issuance Period: 10 years after first issuance of Bonds [NC]
- Reimbursement Agreement Period: 10 years after first issuance of Bonds [NC]
- District Only Tax Rate (Maximum): \$0.6660/\$100 in Assessed Value, subject to TCEQ rules [NC]

Water Services Agreement

Original Water Service Agreement:

- A 2005 CTSUD Agreement, amended in 2013, with the Original Developer
- 308 acres
- 1,100 LUEs Service Commitment
- Prepaid 550 LUEs

Changes from Original Service Agreement:

- Current Developer purchased from the Original Developer:
 - 278 acres
 - 600 LUEs Service Commitment
 - All 550 Prepaid LUEs (or "Credited LUEs")
- City acquired CTSUD CCN and CTSUD water service contracts

New Water Service Agreement:

- Updates Credited LUEs (250 used, 300 remaining)
- Reiterates Service Commitment (600 LUEs)
- On City form, rather than on CTSUD form; replaces Original Water Service Agreement


Existing (PUD and First Amendment Exhibit N):

"Additionally, pedestrian connectivity must be provided throughout the Land as follows:

- Trailheads with signage at key pedestrian access points to the community trail system, as indicated on Exhibit D to the PUD Ordinance.
- A pedestrian connection linking Parcel 2 with Parcel 6.
- Site sensitive, mulch or decomposed granite nature trails within the central ravine as indicated on Exhibit D to the PUD Ordinance.
- 8-foot and 5-foot-wide sidewalks along Road 2 (as described in Section G below shown on Exhibit G to the PUD Ordinance)."

Proposed:

No changes. (The changes in the First Amendment address the River Trail.)
