**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF GEORGETOWN,  
TEXAS, UPDATING EMPLOYEE MEDICAL AND DENTAL PREMIUMS FOR  
THE 2022 PLAN YEAR.**

**WHEREAS**, per Fiscal and Budgetary Policy, annual premiums were recommended to City Council through a collaborative process between the Employee Benefits Committee and external Health Benefits Consulting, using historical data and other analytical analysis.

**WHEREAS**, the Employee Benefits Committee considered multiple options to achieve a 10% medical plan increase and 3% dental plan increase. The City Council has determined that it is appropriate to accept the recommendations of the Employee Benefits Committee and the General Government and Finance Advisory Board consistent with City budget increasing employee medical and dental premiums effective January of 2022 as follows:

Medical

Dental

| <u>Plan Tier</u>      | <u>Monthly Premium effective January 2022</u> |

| Employee Only         | \$2.64  |
| Employee + Child(ren) | \$21.64                                       |
| Employee + Spouse     | \$18.38                                       |
| Employee + Family     | \$43.58                                       |
