ITEM SUMMARY:

In the spring of 2020, City Council authorized an interlocal agreement with the City of Leander to purchase 3 million gallons of water per day to supplement the City of Georgetown's water supply in the western district during peak demand. The agreement requires the City of Georgetown to construct a water metering station.

This project is for the construction of a water control and metering station between the City of Leander water systems and the City of Georgetown water system near the SH29 and Kauffman Loop. This improvement will allow the City of Georgetown to supplement its water supply by purchasing water for the City of Leander.

This project was advertised for public bids on October 28th and November 4th. On November 19th, 2020 at 2:00 p.m. five (5) competitive bids were received as noted below.

- 1. Legion Development LLC \$281,100.00
- 2. Joe Bland Construction \$290,500.00
- 3. Bruce Flanigan Construction \$299,992.00
- 4. JKB Construction Company \$307,077.15
- 5. Royal Vista Inc \$324,400.00

CDM Smith reviewed the bids received to verify for accuracy, workload, and bidders experience. It was determined through this review that while Legion Development submitted the low bid for the project. They did not show experience on at least one of the three projects to be in the Edwards Aquifer Contributing Zone and/or the Edwards Aquifer Recharge Zone as a required per the contract requirements stated in Section 00400, 3.1.1.

CDM Smith also reviewed Joe Bland's bid response to verify accuracy, workload, and bidders experience. It was determined through this review that Joe Bland Construction meets the contract requirements and is qualified to be awarded this contract. Joe Bland has successfully completed several projects for the City of Georgetown over recent years.

STAFF RECOMMENDATIONS:

Staff and CDM Smith recommends the award of a contract for the construction of the Leander Water Connection Improvements Project to Joe Bland Construction, LP of Austin, TX. In the amount of \$290,500.00

Dear Mr. Hallmark:

The Leander Water Connection Improvements Project was advertised for public bids on October 28 and November 4, 2020 in the *Williamson County Sun*. Plans and specifications were made available to interested parties via CivCast.

On November 19, 2020 at 2:00 p.m. bids for the Leander Water Connection Improvements Project were received virtually and then opened and publicly read aloud at the Georgetown Municipal Complex, Purchasing Department, at 300-1 Industrial Avenue, Georgetown, Texas 78626. Five bids were received, and the names of the bidders and total project base bid amounts are summarized below.

1.	Legion Development LLC	\$281,100.00
2.	Joe Bland Construction	\$290,500.00
3.	Bruce Flanigan Construction	\$299,992.00
4.	JKB Construction Company	\$307,077.15
5.	Royal Vista Inc	\$324,400.00

A bid tabulation of all the bid items is attached.

The apparent low bidder on the project is Legion Development LLC. With the bid, each bidder is required to submit a Statement of Bidder's Experience (Section 00400) so that we can determine if they have the experience and qualifications to successfully complete the project. One of the requirements in the Statement of Bidder's Experience is that they demonstrate that they have completed projects on the Edwards Aquifer. In their Statement of Bidder's Experience, Legion Development LLC did not show experience over the Edwards Aquifer per the contract requirement stated in Section 00400, 3.1.1. Furthermore, none of the project experience provided by Legion Development LLC was in the City of Georgetown or surrounding areas. Finally, we were able to

contact two references provided with the bid and neither reference provided a positive statement regarding the work done by Legion Development LLC. Therefore, we do not recommend awarding the contract to Legion Development LLC.

The second low bidder is Joe Bland Construction. As listed in Section 00400, Joe Bland Construction does have experience in constructing projects over the Edwards Aquifer. Joe Bland Construction has successfully completed several pipeline installation projects in Georgetown, illustrating their understanding of the utility interconnection process, easement site constraints, and construction implementation methods required to complete the proposed work. The previous pipeline installation projects include the following projects in the City of Georgetown: Sun City, Rivery Blvd Extension, and Lakeside III. Joe Bland Construction also has current construction projects in the City of Georgetown including Sun City 20, Shadow Canyon, and Silver Spur as well as the Cool Water project nearby in Jarrell, TX.

Based on the information provided in the Statement of Bidder's Experience and the successful completion of previous projects in Georgetown, we believe that Joe Bland Construction can successfully complete the Leander Water Connection Improvements Project as designed and specified. We recommend awarding the Leander Water Connection Improvements project to Joe Bland Construction in the amount of \$290,500.00 (base bid).
