A. Call to Order -- Robyn Densmore, City Secretary

Densmore called to order at 3:30 p.m. and the following members were present - Carlos Hernandez, Dana Hadaway, Tommy Aishman, Judy Butler, Greg Eady, Karen Darby, and Regina Watson.

Members then introduced themselves to the group.

B. Election of Chair and Vice-Chair -- Robyn Densmore, City Secretary
Motion by Watson to nominate Eady to be Chair, second by Hernandez. Eady was agreeable
to being Chair.

Approved 7-0.

Motion by Watson to nominate Hadaway as Vice Chair, second by Darby. Hadaway was agreeable to being Vice Chair.

Approved 7-0.

C. Review of current compensation of the City of Georgetown Councilmembers and a comprehensive review of similar cities -- Robyn Densmore, City Secretary

At the start of the item Densmore noted that the initial attachment for this item showed an incorrect amount and had since been updated. She apologized and added that the original amounts were much higher than the compensation that the Georgetown City Council actually received. Densmore reviewed a chart of other Texas cities with the following pieces of information: 2020 population, number of employees, mayor's annual compensation, council member's annual compensation, number of regular meetings per month, and if the City's provide utilities, a public library, and/or a City airport. She had information from Belton, Cedar Park, College Station, Killeen, Lampasas, Liberty Hill, New Braunfels, Pflugerville, Round Rock, San Marcos, Taylor, and Waco. Densmore noted that she had also reached out to Bastrop, Elgin, Hutto, Leander, and Temple, but had not received feedback yet. She noted that the average annual compensation for those that had responded was \$8,685 for Mayors and \$5,562 for council members.

The board discussed the existing comparable cities and noted the possibility of comparing Georgetown to out of state cities facing similar growth. Densmore offered to research any cities submitted for comparison and would follow up with the initial respondents that had not yet replied with information.

D. Review of time commitments required of the Mayor and Councilmembers -- Robyn Densmore, City Secretary

Hernandez left during this item.

Densmore explained that all members of Council attend Council meetings and board and commission meetings. She added that the City Council meets a minimum of twice per month except in December, and that Council is guaranteed at least one special meeting for budget in July, but possibly two. Densmore added that all members serve on at least one board or commission and some serve on more. She noted that board and commission meetings can range anywhere from 30 minutes to 2 hours, or possibly longer. Densmore then noted that there are other events that Council gets invited to, included, but not limited to groundbreakings, ribbon cuttings, and cultural events.

Members asked that Densmore reach out to the existing Council members and ask them specifically how many hours they are spending on their Council work. Densmore agreed to do so.

COUNCIL COMPENSATION COMMITTEE REPORT TO THE GEORGETOWN MAYOR AND CITY COUNCIL APRIL 2017

The Council Compensation Committee, according to Sec. 2.15 of the City of Georgetown Charter, was appointed by Mayor Ross to review the salaries of the Mayor and Councilmembers and make recommendations regarding those salaries. Committee members included Chair, Jerry Hammerlun, Nancy Gribble-Tay, Richard Glasco, Liz Hobbs, Bob Glandt, Rick Williamson and Llorente Navarrette

The Committee met on December 19, 2016, February 1, 2017 and February 22, 2017. Attached to this summary are copies of the minutes for all those meetings.

The focus of those three meetings were:

<u>December 19, 2016</u> – After introductions, the City Secretary walked the Committee through binders she had prepared that included information on the City Charter, Compensation Comparison and time commitments of the Mayor and Council. The Committee included two former Council Members who shared their perspectives and experiences. The primary focus of the first meeting was to identify additional information that the Committee had a desire to review. At the end of the meeting the Committee again discussed the reality of the time commitment to serve, the importance of a diverse Council and the typical schedule for a Council meeting day. There was also significant discussion related to the diversity and complexity of the issues Council is responsible to oversee.

<u>February 1, 2017</u> – Prior to the Committee's second meeting the City Secretary provided material in response to requests posed in the first meeting. That information included:

- List of Boards & Commissions with Council Member appointments
- List of Events Required of Councilmembers
- List of Events Voluntary for Councilmembers
- List of Cities with Electric Utilities
- List of Cities with Water Utilities
- List of Cities where Councilmembers have paid aides other than the City Secretary staff
- History of Council compensation at the City of Georgetown
- List of Cities with strong/weak mayor government
- List of current Councilmembers working full time outside of civil service position

Each member of the Committee was given an opportunity to ask follow-up questions and comment on the information. The significant volume of documentation that had been provided by the City Secretary made the Committee comfortable to begin a dialogue focused on a compensation recommendation. Feeling there was some consensus for the basis of a recommendation the Chair requested that the Committee meet one more time and that prior to the next meeting each member send their thoughts on a recommendation to the City Secretary.

At the second meeting, the entire Committee was excited about the potential of a suggestion of Member Glasco. Member Glasco's suggestion related to the possibility of having interns from Southwestern University work with the Council and Mayor.

<u>February 22, 2017</u> – This meeting began with a discussion of the estimated hourly rate the Mayor and Council currently receive for their service in relation to the lump sum amount. The Committee's deliberations focused on the following concerns:

- Must continue the positive direction and success of the City.
- Must continue to attract a diverse, professional group of quality individuals willing to serve.
- Must continue to have representation willing to connect with their constituents.

After much discussion, the Committee unanimously (5-0) approved recommending an increase in the lump sum compensation for a Council member to \$1,400 per month and for the Mayor to \$1,800 per month.

ITEM SUMMARY:

The committee will review and discuss the time commitments of Council members during and outside of regular Council meetings.

While still awaiting responses from all Council members, so far, the responses have been:

- About 20 hours per week or 80 hours per month.
- About 30 to 40 hours a week, or roughly 150 hours a month.
- Seldom less than 30 hours per week. Seldom more than 60 hours per week.
- Tried to track my time but it has been impossible. Check email constantly no matter the hour of the day or day of the week; manage city council Facebook page 24/7; phone calls with constituents or city staff almost daily; typically have multiple in person meetings weekly; host town halls; attend HOA meetings; none of this includes council meetings and preparation for council meetings; average over 40 hours a week very easily.
